#### **General Terms and Conditions for Purchases of Kasha**

#### 1. Products Introduction

These Terms set out the terms and conditions attached to the use of this website, call center and Mobile app, for the purchase of products by customers ('Customers') from Kasha Rwanda Ltd ('Kasha') as well as visitors to the site who do not make any purchase.

By using or accessing the Site, Mobile app, USSD or call center you are agreeing to be bound by these Terms in their entirety and we shall bear no liability for the failure of anyone to correctly interpret the Terms. However, Kasha shall provide any clarification on any of the Terms, and we shall respond to any such queries if addressed to the address set out in the 'Contact us' section at the Site.
